This is why I, on behalf of myself and the Eastway-Sheffield Park neighborhood residents as well as East Charlotte as a whole, support the efforts of an organization called "Our Local" to redevelop properties at the corner of Independence Blvd. and Pierson Drive (Varnadore Properties et. al.). These currently vacant properties act as a buffer between Eastway-Sheffield Park and Independence Boulevard. Thus, Our Local's plans to redevelop the historical properties would offer my neighborhood, East Charlotte and, most importantly, all of Charlotte an exciting opportunity to stand out on a world stage, demonstrating our city's progressive attitude, agility, and forward thinking.

Eastway-Sheffield Park neighborhood residents as well as East Charlotte as a whole would surely benefit from the campus-inspired project envisioned by Our Local and like that it is planned to include: a state-of-the-art, aquaponic biotechnology research and development center that would: 1. serve as a home to a new international aquaponics school, offering education and community gardening opportunities, 2. serve as a pick your own produce grocery store, and 3. provide a platform for scientific research. As a result, we view the LED installation as an arts medium that would enhance our community and therefore support this element being included in this project as proposed.

Organizations willing to take the risk with private money to soundly redevelop areas regarded as undesirable by most deserve our support. This is especially true when such efforts are community inspired and would likely spark further development, engage and uplift the surrounding community, create new jobs, improve the area's tax-base, and strengthen connections.
